- I have obtained all information required or useful regarding all aspects pertaining to the transfer of the Securities to NBDB;
- I acknowledge that I understand the fiscal impact of this transfer;
- At no time did NBDB counsel or give me legal advice regarding this transfer or, specifically, concerning the resulting tax treatment;
- I undertake to indemnify NBDB for any damage or loss it may suffer in relation to the transfer of the Securities, including without limitation, in relation to any claims of a fiscal nature; and
- I hereby acknowledge that this declaration is an essential condition without which NBDB would not have authorized the transfer of the Securities as specifically requested by me.
